Some 2009 Taurus X and Sable, 2009-2010 Edge, MKX, Explorer, Explorer Sport Trac, Focus, Taurus, 2010 Mustang and E-Series vehicles equipped with SYNC may experience concerns with Phone/USB connectivity and voice recognition. Some 2010 vehicles equipped with Traffic, Directions and Information (TDI) receive improved SYNC notification messaging.

ACTION

Follow the Service Procedure steps to correct the condition.

SERVICE PROCEDURE

- Verify if a SYNC update is available. Go to the Professional Technician Society (PTS) website and from the OASIS tab select the SYNC button. Scroll to the bottom of the page, under software update actions and click on the (View Latest Software) hyper link located next to the standard selection.
 - a. If no software updates are shown available, this article does not apply. Refer to Workshop Manual (WSM), Section 415-00 for normal diagnosis.
 - b. If software updates are available, ensure that the Integrated Diagnostic Software (IDS) release is at 79.02 or higher, then close the IDS software and proceed to Step 2.

 Reprogram the Accessory Protocol Interface Module (APIM). To perform the reprogram it will be necessary to follow the online version of the WSM, Section 418-01 Accessory Protocol Interface Module APIM - Standard programming.
